



# This document outlines how Meander Valley Council administers the Meander Valley School Award.

We take a grounded and practical approach, ensuring projects reflect the needs and aspirations of our community. Grants are awarded to initiatives that enrich our Valley—whether by strengthening connections, supporting local organisations, or enhancing the places we call home.

## This document outlines how Meander Valley Council administer the Meander Valley School Award.

## What is a Meander Valley School Award?

- This award is an incentive and recognition award offered to Meander Valley school students that demonstrate, throughout the school year, values that align with Meander Valley's Community Strategic Plan values and Place Brand principles.
- The Meander Valley School Award is part of Council's Community Grants and Sponsorship Fund to which an amount is allocated annually.

## Who is eligible for an award?

• All Department of Education, Children and Young People (DECYP) Schools in the Meander Valley local government area are eligible for a Meander Valley School Award. Each Meander Valley (DECYP) School will be responsible for selecting one student to receive this award at their annual presentation evening.

All Meander Valley (DCEYP) Schools are eligible. A Community Wellbeing staff member will contact each of these eligible schools in October to discuss the award and the specific award criteria that is planned for your School.

#### Schools will need to submit the following details to Council:

- The date and time of their award presentation evening;
- A School contact person;
- Their nominated student award winner;
- Whether it is suitable for a Councillor or Staff member to present the award.
- The nature of the award they are presenting and its alignment with the Meander Valley's Community Strategic Plan values and Place Brand principles.

## What is the value of the Award?

• The Meander Valley Award will be to the value of \$150 and schools are only eligible for one award per year.

# When will the award be provided to schools?

- The award funding will be processed prior to the school hosting its annual presentation evening.
- Schools will be encouraged to invite a Meander Valley Council representative (Mayor, Deputy Mayor, Councillor or staff member) to present the award at the presentation evening.

## How will schools be paid?

• On receipt of all required information, an invoice and completed EFT form, Council can pay the award amount via Electronic Funds Transfer (EFT).

## What is the process for receiving the award from Council?

A Community Wellbeing team member will be in contact with each of the eligible schools in October to discuss the award, the criteria and the presentation requirements.

#### Award criteria can include reference to Meander Valley values such as:

- Inclusiveness through sharing, embracing diversity, fostering belonging and strengthening connections;
- Environmental stewardship via protecting and preserving our natural environment;
- Being Innovative and creative from demonstrating innovative ideas and treading your own path forward;
- Acknowledging Heritage: by honouring, practising and preserving our natural or cultural heritage; and
- Being collaborative through working together as a team to bring a vision to life.
